By accessing, browsing and using this site you acknowledges that you have read, understood and agree to be bound by this Privacy Agreement and to comply with all applicable laws and regulations. We have designed this Privacy Policy to explain how we handle personally identifiable information collected from users who register for services and submit information to (www.jaldicash.com) through the Internet. If you do not agree to these terms, do not use this site. Read this Privacy Agreement carefully and be aware that Weizmann Impex Service Enterprise Ltd WISE may amend this Privacy Agreement at any time without notice and by posting the amended terms on this site. Weizmann Impex Service Enterprise Privacy Principles:

Our core businesses include technology enabled services i.e. “Jaldi Cash” a unique payment instrument available for Indian consumer, which is safe and convenient to transact. It is a smart option for all, and the safest online and on–mobile transaction instrument. Jaldi Cash may be used for transferring funds to Banks accounts, other Jaldi Cash Card (instrument holders), making payment of utility bills & essential services. Jaldi Cash is a full usage product which empowers you to do online transactions at any time and from anywhere or through any of our authorized Franchisee / Retail Outlets. Through our portfolio of varied online services, spanning from Travel booking to Insurance, from Utility Bill Payments to Mobile Top-ups, we plan to add new dimensions to the business of retailing. These are confidential matters and Jaldi Cash and its affiliates recognize your expectations regarding privacy policy of WISE. WISE is committed to keep your information confidential and secure and that is why we have designed procedures to ensure your privacy in all facets of our relationship. No matter if you are our Merchant, business partner, franchisee / retailer, backend user, a consumer, and a customer you are protected, not only by the applicable privacy laws, but, more importantly, commitment of WISE to safeguard your privacy and your right to decide how your personal information will be used.

Scope of Privacy Policy:

This Privacy Policy covers treatment of personally identifiable information collected by WISE from our merchants, franchisees and registered users who use the Jaldi Cash Services, it payment gateway services, as well as Merchants’ information that we have tie-up and acquire

in the course of our business. This Policy also covers the treatment of personally identifiable information that our back end technology service providers / partners may share with us.

This Policy does not apply to the practices of companies that WISE does not own or control or to people that WISE does not employ or manage. This Policy is specific to WISE and does not apply to other Web sites, links or Internet services that are part of or to be part of the Network of WISE.

What Personally Identifiable Information is collected by Jaldi Cash?

Jaldi Cash collects and stores information collected from our customers, franchises and end users who use the Jaldi Cash Services, its payment gateway services, as well as Merchants, business partners, that we have tied-up and acquired in the course of our business and some visitor information regarding usage of this website, such as date and time of day you access our website, browser type, browser language, the Internet Protocol (IP) address of the computer you are using, number of hits, the pages visited, previous/subsequent sites visited and length of user session. WISE does not collect any unique information about you (such as your name, e-mail address, etc.) except when you specifically and know WISE only provide such information.

Objective:

1. Provide consumers notice of our information practices.
2. Offer consumers choices as to how their information is used beyond the purpose for which the information was provided.
3. Offer consumers reasonable access to their information and an opportunity to correct inaccuracies.
4. Take reasonable steps to protect the security and integrity of personal information.

WISE respects your privacy and wants to promote trust and confidence on the internet. As such, WISE feels it is necessary to disclose to you what information this site collects and tracks and what we do with the information that we collect.

Information security is critical to our business. We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you input. We store information gathered on secure computers. It is important for you to protect against unauthorized access to your Login ID/password and to your computer. Be sure to sign off when finished using a shared computer and otherwise protect the password used to access the services of WISE.

Currently, WISE collects information of our customers, franchises and end users who use the Jaldi Cash payment gateway services, as well as Merchants, business partners that we have tied-up and acquired in the course of our business. WISE asks merchants and customers to supply various personal data when placing an order, such as name and address, telephone number, and E-mail address. WISE uses this data only for the purpose of filling an order, or

communicating with the customer or Merchants about the status of an order. The data so collected is used in the aggregate to give us demographic information about the entire services of WISE in order to improve the said service to you, to perform statistical analysis of the collective characteristics and behavior of our Merchants, customers/users and visitors, to measure overall patron demographics and interests regarding specific areas of the jaldicash.com domain and to analyze how and where to use our resources. We use cookies to help us determine which sites users' link to, and which services merchants and visitors use.

We also track information like the domain name from which you contact us, the pages you request, the products you buy, the referring site, and the time that you spend on the site. For everyone who visits our website, Sub-Merchant purchase page, we log IP addresses, the type of operating system that your computer uses, and the type of browser software used by you. From the IP address, we can determine the Internet Service Provider and the geographic location of your point of connectivity.

If you are our Merchant or franchisee then the personal information you provide – name, address, etc.-allows us to inform you about updates, or changes to the service and to notify you of products and services of WISE, its backend service providers and affiliates that we believe may be of interest to you.

How WISE uses and share Personally-Identifiable Information:

At our website, we will use your personal details and information we obtain from other sources to provide you with our goods and services, for administration and customer services, to analyze your preferences and to ensure that the content, services and advertising we offer are tailored to your needs and interests. Personally identifiable consumer information is also shared with third parties (such as our Merchants, Banks and credit card/prepaid card processors, franchises, business partners, and channel network) service providers, agents to the extent necessary for WISE to deliver payment settlement/processing services. WISE may also link to a wide variety of other sites/links. We are not responsible for their privacy policies or how they treat information about their users. We may disclose personal data in order to comply with a legal or regulatory obligation.

If you (i.e. our Merchant, business partner, franchises, aggregators) would like to view the information we have collected from you and your customers or you want to correct your information or the billing/shipping details of your customers or their IP addresses, Please go to Login page and log into your account to view the above details and to review your personal information. Cookies:

The information mentioned above is gathered by using cookie. A cookie is a small line of text that is stored by your browser on your computer's hard drive. Our cookies do not contain any personally identifiable information.

We use cookies to collect information about how this site is used. We use this information to improve how our website caters for your needs and to identify any technical problems.

Cookies are small bits of data that are stored by your browser. You can accept or decline cookies by modifying the settings of your web browser.

When you visit our website, we may also log your IP address, a unique identifier for your computer or other access device.

The internet is worldwide and if you are visiting this site from outside India, your visit will necessarily result in the transfer of information across international borders. By visiting this site and communicating electronically with us you are consenting to these transfers.
